Rittman Academy Annual Report 2022-2023

Mission Statement

Our mission is to enhance and facilitate student learning by utilizing an educational model that combines state-of-the-art digital curriculum and instruction with access to local school resources to complement that instruction and prepare students to become life-long learners and productive citizens.

Our Program

The Rittman Academy was established in 2005. Rittman Academy is designated as a Drop-out Prevention Credit Recovery (DOPR) Community School. Rittman Academy serves a student population of grades 9-12. The majority of our student population enters our school at risk of not earning a high school diploma due to credit deficiency and also economic disadvantages.

Rittman Academy students are on a 6 hour school day. Students are expected to attend school every day school is in session. Students have some options for credit flexibility. These can account for seat time as well as academic credit and must be arranged in advance with our licensed Career Based Intervention (CBI) teacher and verified to relate back to academic goals and standards.

The curriculum is computer based and aligned to the standards set by the state of Ohio. The software is provided by Peak and is called FuelEd.

Our staff of highly qualified teachers work with our students on an individual basis to assist them in achieving academic success.

Partnerships

*Staffing and support is provided by the Tri-County Educational Service Center (ESC) located in Wooster, OH.

*Special services (testing) are provided by the Rittman Exempted Village School District.

*Food service (optional) is provided by the Rittman Exempted Village School District.

*Technology support comes from the Tri-County ESC and from the Rittman Exempted Village School District.

*A counselor, a case manager and also staff professional development is provided by ANA-ZAO Community Partners

*The Rittman Academy is housed in Heritage Hall. This building was formerly Rittman High School.

* The Goodwill provides work skills training including financial literacy and career planning and navigation.

Enrollment (Student Population 2022-2023)

The Rittman Academy started the school year in August of 2022 with 34 students. The student enrollment fluctuated throughout the school year and ended with 37 students in June of 2023.

Daily attendance average was 74.9%. This was up from 67.6% the previous year.

During the 2022-2023 school year, 95% of the students were considered to be economically disadvantaged.

The student population consisted of 90% Caucasian students and 10% minority students for the 2022-2023 school year.

During the 2022-2023 school year, 23% of our students received special education services.

Eight students received their high school diploma from the Rittman Academy during the 2022-2023 school year.

Academic Goals

Through the use of state-of-the-art on-line curriculum, our students will make academic progress. This will happen at their own pace with the assistance of our teaching staff.

Ultimately, the goal for all students is to earn a high school diploma. This might come directly through the Rittman Academy or by attending the Wayne County Schools Career Center and learning a trade.

In addition to making consistent and steady progress in coursework, students will learn the hard and soft skills needed to become productive in the workplace. Through our staff, guest speakers, CBI courses and CBI lab, we will emphasize what is necessary for job readiness and employment.

Rittman Academy is currently in year three of its three-year ONE Plan. Rittman Academy's three-year plan goals include: 1. 100% of students who are unable to demonstrate proficiency at grade level math and reading will be given targeted intervention within two weeks of beginning classes. 2. 100% of teachers will receive trauma informed and PBIS training by May 2022. The Building Leadership Team (BLT) will work with teachers to determine school-wide Tier-1 supports to be implemented throughout the 2022-2023 and 2023-2024 school years. 3. 100% of students will set monthly goals with their teacher mentor and will conference no less often than monthly to evaluate progress toward attendance and academic goals.

During the 2022-2023 school year, Rittman Academy met the goals of offering targeted intervention to students who could not show proficiency in math and/or reading. The STAR assessment was used to measure proficiency. 100% of teachers received trauma informed and PBIS training from a trainer provided to us at no cost by Ana-Zao Community Partners. Students were assigned teacher mentors with whom they met at least twice per month to track and assess academic progress.

Testing

Rittman Academy used the STAR reading and STAR math test, in addition to teacher-created formative assessments and also observational data, to assess gains in student learning and areas of needed intervention. Data was collected from 100% of students and intervention was offered to all students who scored at the intervention or urgent intervention levels.

State Report Card

Districts and schools report information for the Ohio School Report Cards on specific marks of performance. Schools that receive the dropout prevention and recovery report card, as Rittman Academy does, receive ratings for up to eight measures and four components.

High School Assessment Achievement Grade: Not Rated

This represents student performance on state tests.

Progress Component: Exceeds Standards

The progress component looks at the growth all students are making during the school year.

Gap Closing: Does Not Meet Standards

This component shows how well schools are improving or meeting the performance expectations for all students in English language arts, math, graduation, and English language proficiency.

Graduation Rates: Exceeds Standards

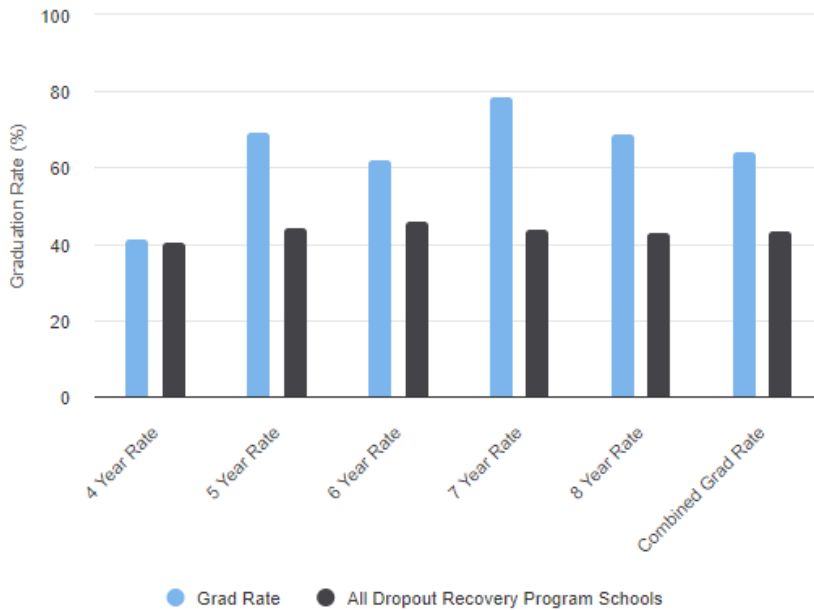
The Graduation Rate component looks at the percent of students who are successfully finishing high school with a diploma in four, five, six, seven or eight years.

41.7% of students graduated in 4 years - Exceeds Standards

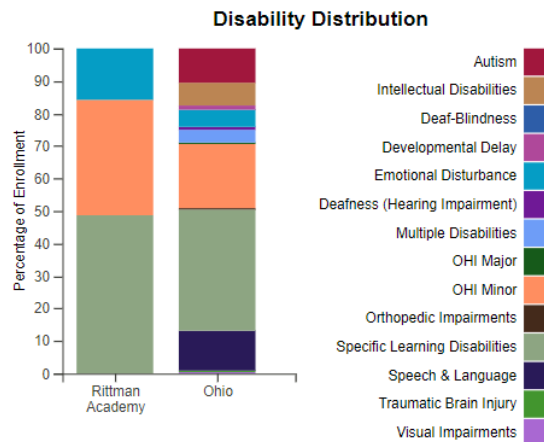
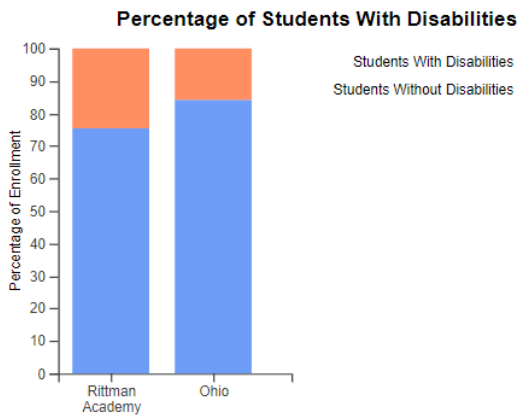
69.7% of students graduated in 5 years - Exceeds Standards

Operations

The school was found to be financially stable. No findings came from the auditor against the Rittman Academy for the 2022-2023 school year. Additionally, Rittman Academy was awarded the Ohio Auditor of State Award. This award was presented to our treasurer, Mark Dickerhoof, by a representative from the Auditor of State's office at our September 2023 governing board meeting.

Financial Condition

The Rittman Academy is in sound financial condition. For the 2022-2023 school year:

This is an increase from the previous years' positive cash flow of \$39,193.50.

Statement from Sponsor

Ohio Revised Code (ORC) 3314.03(D)(2) specifies that the sponsor of the school must "monitor and evaluate the academic and fiscal performance and the organization and operation of the community school on at least an annual basis."

In its evaluation of the school performance, the Ohio Department of Education's Office of Ohio School Sponsorship assesses the performance of Rittman Academy on each of the required Ohio School Report Card indicators and on performance measures listed in the charter contract.

The Ohio Department of Education's Office of Ohio School Sponsorship monitors the performance of the community schools through our attendance at the Rittman Academy board meetings, visits to the school, monthly review of financial reports and reviews of academic progress reports along with other reports related to the school's performance.

The Ohio Department of Education's Office of Ohio School Sponsorship was the sponsor for Rittman Academy during the 2021-2022 school year. The Rittman Academy was generally compliant with the laws, rules, and regulations governing Ohio community schools and we continue to monitor compliance with laws, rules and regulations throughout the school year. Academically, Rittman Academy is progressing towards compliance in academics and we will continue to provide technical assistance and monitoring of school academics.

The Annual Report for Rittman Academy related to the performance of the school and all other schools sponsored by the Ohio Department of Education will be posted on our website www.education.ohio.gov, no later than October 30, 2023.
